Mission

"To prepare knowledgeable and effective teachers for education and training of children with autism and associated disabilities."

About the College

Suvidya College of Special Education was established in 2015 by Society of Parents of Children with Autistic Disorders (SOPAN) with the purpose of training teachers as human resources in the field of disability rehabilitation.

The college is affiliated to University of Mumbai and recognized by the Rehabilitation Council of India.

Suvidya College is NAAC Accredited.

The overarching goal is to provide knowledge, enhance attitude, behaviour and skills through teacher education in both pre-service and in-service programs to educate children with autism and associated disorders.

Programmes at Suvidya College:

- B.Ed. Special Education (Autism Special Education)
- Short Term Courses
- Continued Rehabilitation Education (CRE) programs approved by Rehabilitation Council of India
- National and International Conferences, Seminars and Workshops on best practices in the field of disability

Activities at Suvidya College

The objectives of the B.Ed. programme are to develop competencies to primarily teach children with autism in special as well as inclusive schools. Students are also given opportunities to develop competencies to teach children with cross disabilities.

The programme also includes courses which enhance knowledge and skills related to professional development. The academic activities are aligned to further contribute towards the overall personality development of the students.

Visits and Classroom Observations:

It is necessary to understand the environment in which children learn to be able to teach. The syllabus for practicum includes visits and observations of children with special needs including autism. In semester 1, the B.Ed. students understand the physical environment as they learn accessibility in their theory for other disabilities.

Students of Batch IX visited the following schools and institutions during this semester (October 2023 to March 2024).

In semester 2, they learn classroom management of children with autism. They are placed in the SOPAN special schools where they play the role of assistant teachers and understand the teacher – student roles and relationships. Students of Batch IX completed their observations in March and April, 2024.

Batch VIII completed their observation of support services at Muskan Foundation at the Bandra and Goregaon centres on January 18, 2024.

Practice of Teaching at Special and Inclusive Schools:

Semester III focuses on the core disability, autism spectrum disorders. The students of batch VIII planned and conducted lessons based on teaching strategies taught. Five lessons were conducted based on Discrete Trial Training at Samarpan Special School between, November 28 to December 01, 2023. Further, they also completed lessons based on TEACCH systems at Samarpan Special School, Saksham Sheltered Workshop and Natwar Nagar Mahanagarpalika Vishesh Shalla (Divyang) during the semester.

Semester IV, being for cross disability, students of batch VIII conducted lessons at various schools both inclusive (at the resource centres) and special schools with children with Learning Disability and Intellectual Disability. They completed five group teaching lessons at CASE SRCC from March 18 – 22, 2024 and five lessons at GAET Counselling Centre from April 22 – 25, 2024.

Case Studies and Internships:

As part of the semester 3 theory paper on ASD: Teaching Approaches and Strategies, students of Batch VIII completed their case study on early intervention at Spandan Early Intervention Centre from October 09 – 16, 2023. They conducted assessments, intervention based on DIR Floortime Strategy and compiled a report along with the IFSP for the child.

Students also conducted a case study for older children with autism at Samarpan Special School, Shanay Autism Centre, New Panvel between December 18, 2023 and January 11, 2024. They prepared an assessment kit and conducted a psycho-educational assessment based on the EACA. They then completed intervention based on the findings during assessment and submitted the report along with the IEP.

Students are placed at two schools for internship, one is Autism specific and the other either at an inclusive school or at a special school for any other disability. Batch VIII completed their internship in inclusive special needs classrooms at CASE SRCC and at SOPAN's Samarpan Special School for autism in February and March 2024.

Development of Material:

Batch VIII, developed three social stories and four TEACCH systems during semester III which they demonstrated the use and wrote a lesson plan. These were observed and marked by the faculty and a viva was taken for the same.

They also adapted two lesson units of different levels of school subjects and submitted to the faculty.

Students of Batch VIII, during semester IV, developed informal tests for children with learning disability which they used at CASE SRCC for their case study assessment in March 2024. They also developed interactive power point presentations for teaching Home Science, NIOS for two chapters each. They taught the children of NIOS using these in May 2024.

Enhancing Theoretical Learning:

Practical training sessions by Ms Reshma Gaikwad on Discrete Trial Training in October 2023 with semester III students of Batch VIII.

Demonstrations and guided practice is given for DIR Floortime, TEACCH and use of Visual Strategies in the classroom.

Systematic Observation and functional assessment of behaviour which is taught in the Applied Behaviour Analysis course in semester III is also guided and practiced in classrooms.

Community Outreach:

- SOPAN being an NGO conducts awareness programmes during the month of April for autism. Students at Suvidya College actively plan and create posters, enact street plays or puppet shows during exhibitions held on October 30 & 31, 2023 in Goregaon and Andheri.
- B.Ed. students of Batches VIII and IX went on a community tour to Valsad and Pardi in the state of Gujarat on March 27 & 28, 2024. They worked with children with special needs in their classrooms on lessons like sequencing a story, mathematics and visual perception activities. They also prepared and played

games like obstacle walk, made handicraft articles and presented a puppet show with songs and music.

Gender Sensitivity:

 An online session on 'Gender Sensitivity' was held on May 05, 2024 with Dr Tanuja Prem, Psychologist and Special Educator and founder of Education Matters.

Workshops and Webinars:

- a) Two day workshop on Art Forms of India was held on June 06 & 13, 2023 where the students learned to draw and paint art forms like Gondh, Warli and Madhubani. The sessions were conducted by Ms. Prameela Menon, a Fine Artist and Teacher.
- b) A talk by Ex- RCI Chairperson, Prof. Sudesh Mukhopadhyay was conducted at the college for B.Ed. students and faculty on June 19, 2023, titled, 'NEP & NCF: Relevance of Education of Children with Special Needs' it was an IQAC initiative.
- c) Two day workshop on 'Using Multi-sensory Resources in the Classroom was held on July 15 and August 20, 2023. The resource person was Ms. Darshana Patwa, a Special Educator and an, Arts based Therapy Practitioner.
- d) A Skill Building Workshop was held at Shanay Autism Centre on August 20, 2023 where the resource person was Ms. Anjali Venkat.
- e) Group discussion on Mental Health was facilitated by Mrs Sadri on World Mental Health Day, October 10, 2023.
- f) The IQAC organized a webinar on, 'Importance of AI and AI Tools' with Ms Rakhee Chhabria as a resource person and 'Creating an Effective Personal Brand' with Ms Nisha Gupta as a resource person in January 2024.
- g) Skill Development for Persons with Special Needs, a career fair was organized at CASE SRCC. B.Ed. students volunteered on March 21, 2024.
- h) A phonics workshop was conducted by Mrs Imam for the students on April 30, 2024.
- i) A three part series of webinars were conducted in Augmenting Learning for the students and alumni on Literacy Skills: Reading, Executive Functioning: Early

Experiences and Development and Autism and Technology between March and April 2024.

Scholarships:

Four students received scholarships in 2023 – 24 in the Rajashi Chhatrapati Shahu Maharaj Shikshan Shulk Shishyavrutti Scheme.

Alumni Contributions:

- Mrs Reshma Gaikwad conducted lectures in autism for the B.Ed. students and guides and supervises practicum with children with autism at Samarpan Special School where she is a coordinator.
- Mrs Tanuja Prem conducted a two-day workshop on Drama in Education for both the batches. Further she also conducted the 'Gender Sensitivity' Workshop for batches VIII and IX.
- The alumni group also contributes with offering information on placement options.

The Short Term Certificate Courses meant for parents and professionals are aimed to enhance their capacities as stakeholders in the field of Rehabilitation. Suvidya College plans these programmes every year where in-house faculty and experts in the field come together as resource persons and share their knowledge and experiences.

- ❖ Short Term Certificate Course in Specific Learning Disability in the online mode was held from April to June 2024. There were 18 participants.
- ❖ Short Term Certificate Course in Autism Spectrum Disorders in the online mode was from July to September 2023. We have 12 participants.
